Fall from low height (eg. chair / step ladder)
Hit by moving, flying or falling object
Hit something fixed or Stationary
Hit by a moving vehicle
Injured by an Animal
Injury to patient/staff moving and handling
Moving and Handling incident (Not involving patient)
Needle stick injury
Slip, trip or fall
Trap injury
NEVER EVENT - Fall from poorly restricted window
